During his tenure at NSA, Mr. Penrose served in several senior leadership roles including as the Technical Director for Counterterrorism during the time that Usama Bin Laden was brought to justice. He also was a founding member of the NSA/CSS Threat Operations Center (NTOC) where he served as the first NTOC Mission Manager and supported both offensive and defensive cyber operations planning and execution.



Jim also played key Technical Director roles across the Signals Intelligence (SIGINT) Directorate to include Tailored Access Operations (TAO) and SIGINT Support to Information Operations. In addition, he was detailed to the Central Intelligence Agency's Counterterrorism Center to provide cyber operations expertise in support of human intelligence. His extensive experience spans all manner of cyber operations and his unique blend of intelligence community experience and private sector business acumen is indispensable in solving the most challenging problems and growing new businesses in the cybersecurity technology space.

Prior to joining Tranquility Cybersecurity International, Limited (TCI), Jim served as the Chief Operating Officer of the cybersecurity firm BlueVoyant. He was responsible for all operational aspects of BlueVoyant's business focused on day-to-day cybersecurity delivery and execution. He was the primary driver responsible for innovating BlueVoyant's Cyber Risk Management Services offering. He personally spearheaded the growth of BlueVoyant by building product, engineering, sales, and marketing capabilities to take the Cyber Risk Management Services offering from concept to full operations to include the acquisition of marquee reference customers over an 18-month period. Jim also supported fundraising during the Covid-19 crisis to retain his workforce and continued company operations with no degradation in service throughout the pandemic, raising more than \$40MM in additional capital to sustain and expand the firm's operations. He contributed to the firm tripling its revenue and increasing its valuation from \$400MM to approximately \$2.4B.
